JEFFERSON ECONOMIC DEVELOPMENT CORPORATION, INC. QUARTERLY REPORT

For the Quarter: 10/1/2019 through 12/31/19

Actions

The board is in the process of compiling certain written policies and procedures which will be of use to future boards.

On 11/22/19, Dr. John Cooper from Texas A&M held a presentation here in Jefferson setting out the benefits of comprehensive strategic planning for the City. This presentation was attended by the Mayor, several members of the Jedco board and City Council as well as interested citizens. Jedco will be discussing strategic planning in upcoming meetings.

Financial

At the beginning of the quarter the general account at First National Bank was \$619,170.18; at the end of the quarter the balance was \$638,096.73. The USDA account at First National Bank was \$90,196.83 at the beginning of the quarter and \$91,096.83 at the end of the quarter. The Texpool account was \$58,867.24 at the beginning of the quarter and \$59046.76 at the end of the quarter.

During the quarter, JEDCO received \$72,526.55 in sales tax revenue from the City.

Grant expenses for the quarter were as follows: As part of the Fikes/Cefco project: \$2,200 to the City for water and sewer taps, \$1,400 to Arrow Plumbing for a temporary water line to Wayne's Pro Lube, and the initial incentive payment to Fikes in the amount of \$50,000.00.

The only outstanding loan is to Richard and Karen Penner. This loan was made on 5/26/17 in the original amount of \$30,000.00 at a rate of 3.5% from USDA funds. It is set up as a 5 year, monthly pay note on a ten year amortization with a balloon payment of \$16,603.75 at the end of the five year term. The outstanding principal balance is \$25,733.75 as of 12/31/2019.

According to the new budget, JEDCO will incur a \$75,905 deficit in fiscal year 10/1/2019 through 9/30/2020, due primarily to economic incentives to be paid as a result off the Fikes project. This shortfall will be covered from cash reserves on hand.

Copies of monthly financial reports and a copy of the budget accompany this report. Also attached is a copy of the budget for the fiscal year beginning 10/1/2019.
